- The auction call documents can be obtained from Section Officer, Office of the Divisional Forest Officer, Rourkela Forest Division from Date 05.11.2024 on working hour from 10.00 A.M. to 5.00 P.M or can be downloaded from the website www.odishaforest.in / www.dforourkela.in / www.sundargarh.odisha.gov.in on payment of a non-refundable cash or Demand Draft amounting to Rs.500/- (Rupees Five Hundred) only drawn in favour of the Divisional Forest Officer, Rourkela Forest Division payable at SBI, Rourkela from the date of publication of auction notice up to 14.11.2024. One application is required to be used for one vehicle.
- The bidder may inspect the vehicles well in advance before submitting their application.
- Participation in the auction process and submission of application shall be
 deemed as a proof that the bidder has inspected the vehicle and satisfied
 himself about its condition. Neither any complaint at later stage shall be
 entertained nor shall any claim for grant of refund of deposited amount will be
 entertained under any ground, whatsoever after the tender is finalized. The
 department will not be held responsible for any dispute regarding the condition
 of the vehicle after the sale.
- The interested individual or farms shall submit Earnest Money deposit (EMD) for Rs. 5000 /- (Rupees Five Thousand) only in shape of Demand Draft drawn from State Bank India, in favour of the Divisional Forest Officer, Rourkela Forest Division and the EMD must be submitted along with the auction paper in a sealed cover.
- The auction paper along with all connected documents in sealed cover shall reach to O/o the Divisional Forest Officer, Rourkela at Panposh either by registered/speed post/in person can be dropped in the tender box kept in the division office by 16.11.2024 up to 05:00 PM.

- Cash deposit shall not be entertained at any stage. In case of successful bidder, the E.M.D will be adjusted towards security deposit and in case of unsuccessful bidder, the EMD will be refunded in due course with proper acknowledgement to the bidder or their authorised representative.
- The application forms should be filled up clearly and legibly in English or Odia language only. Correction and overwriting, if any, should be attested by the bidder. The full name and complete postal address of the bidder should be clearly written in the form. The application without signature or without E.M.D will be summarily rejected.
- The bidder has to mention his PAN Number, GST Number on the form and submit self attested photocopies of the same with the application form. Self attested photocopy of the quarterly GST return up to March 2024 should also be submitted along with application Form. The bidder should enclose a photocopy of the voter ID card / PAN card as proof of his identity.
- One individual may file application for more than one vehicle. However for each
 vehicle there shall be individual application and E.M.D. The registration No. of
 the vehicle sought to be purchased should be written in red ink on top right
 hand corner of the envelope.
- The bidder who will qualify in the 1st phase of document verification will be allowed to participate in the auction call on 18.11.2024.
- The auction shall be conducted on dated 18.11.2024 in the Office of the undersigned at 03:00P.M in the presence of the bidder.
- The auction paper without Earnest Money Deposit and if received beyond the stipulated time shall be rejected.
- No one except intending bidder who deposits EMD of Rs.5000/- (Rupees Five Thousand) only will be allowed to participate in the auction sale.
- The vehicle available at different places as mentioned in column No. 6 of the table in Annexure-I can be inspected by the bidder on any working day between 11.00 A.M to 5.00 P.M.
- The highest successful bidder shall have to pay security deposit 25% of the final bidding amount in shape of cash on the spot immediately after the announcement of the auction, this amount will be adjusted towards sale value.

nce the auction is over, the bidder shall have to pay the rest 75% of the bidding mount within 7 (Seven) days from the date of confirmation of the auction, failing which ground rent @10% of the auctioned amount shall be charged for each day or part till removal of the vehicle from the site.

- Taxes i.e. GST and Income Tax with surcharges as per prevailing rate will be borne by the bidder / purchaser on the sale value.
- The custody and safe guard of the vehicle beyond the date of deposit of full
 auctioned amount shall be responsible of the successful bidder and no claim or
 complain on the mishap of the vehicle shall be entertained.
- The successful bidder if fails to deposit the full sale value and the taxes levied thereof, within the stipulated date line, the undersigned will be at liberty to forfeit the entire amount (Including earnest money) deposited by the bidder to Government and the vehicle will be put to fresh auction sale.
- In case, the ground rent charges exceed the sale price deposited by the highest bidder shall cease to have any right to claim on the vehicle. The amount deposited by him towards sale price shall be adjusted towards ground rent and the vehicle become absolute property of Odisha Forest Department and will be disposed of by fresh auction sale.
- If minimum price is not fetched by auction sale, the DFO may dispose of the vehicle through negotiation at a price not less than the approved price. Priority will be given to the highest bidder while the vehicle will dispose of through negotiation, if a vehicle put to auction sale will not fetch the upset price during auction process or negotiation the vehicle will again put to fresh auction sale.
- Since these are confiscated vehicles seized in different Forest Offence Case, toolkits, R.C. Book, insurance papers and implement etc can be provided to the highest bidder subject to its availability.
- The undersigned is not liable for any other previous litigation pending i.e. road tax, insurance etc and for change of ownership of the confiscated vehicle.
- The authority reserves the right to accept or reject any auction without assigning any reasons thereof. In case of any dispute, the decision of the competent authority i.e. Divisional Forest Officer, Rourkela Forest Division shall be final and binding.
